2nd March: AVRMC – Free medical tests:

Free treatments/ medical lab tests were arranged for the elders at Arupadai Veedu Medical College, whom were scrutinised for medical check during the campaign held at TEV campus by the end of February 09. As per the AVRMC – Medical college Dean's permission, about 14 elders were taken complete medical check, lab tests, ECG, X-ray and elders Jeyamma (severe anaemic), Krishnasamy (multiple furunclulosis), Murugiah (IHT) were undergone free treatment as inpatients for about a week in AVMC Hospital.

3rd March: Elders Meeting at TEV

TEV elders meeting was conducted at TEV open air theatre by 5 pm. The meeting was arranged by Residents representative council this time. The following points were discussed and resolutions were made.

- ♣ Elders whom were admitted in hospitals would be taken care by the active elders, prearranged by the Elders care committee
- Rameshwaram temple visit should be finalised with manager and a bus could be arranged
- Watering of plants in both green shades and around the pond area will be maintained by Agri. Committee. 5 more water pots to be purchased.
- ♣ Profit from the Income generation training programmes could be shared among the residents with prior permission

4th March: Case Presentation by the Care givers.

Caregivers are advised to present the case histories of at least 3 elders each/ week in front



of the Manager and Senior caregivers. The resident applicant case presentation includes his/her family history, birth, marital, medical histories, possessions if any and reason for applying to TEV.

5th March: First Aid training for caregivers

First Aid – training cum orientation training was given to all the caregivers by the senior care givers team. They discussed about usage of emergency medicines, bandage techniques, care for burns. cutting and fall injuries. Orientation training was arranged on the same day for all the old and new staff on Standard Operating Procedures, ground rules formulated by the residents, elder's management committees, role of senior manager explained etc was Mr.Siddick, TEV Manager.

6th March: TEV Staff meeting

TEV staff meeting was organised at Infirmary on 6th March. Mr.Elango attended. Following points were discussed.

- Daily reporting by Senior caregivers
- Medical care, IGP and provisions, Maintenance and cleaning were to be looked after by each of senior caregivers
- ♣ Provisions/ toiletries request should be submitted with duly approvals to APO well advanced
- Medicine requirements should be submitted with Doctors approval.
- ♣ Provisions/ toiletries/ medicine purchase, entry and issues could be maintained by senior care givers.
- Vehicle requisitions and doctors advice is required before taking elders to GH or any other hospitals for treatment.
- ♣ Caregiver's duty roster/ elders under medication / status of residents etc should be written and displayed daily on the white board provided.

7th March: Internal Auditors from HelpAge India, New Delhi visit

The auditors from HelpAge India Mr.Lal Mohan Singh and Mr.Swami visited TEV on 7th March. They audited project wise and gave suggestions / remarks on stock register maintenance, purchase and issue procedures, medicine stock check, accounts entries in tally etc. Earlier, Mr.Ramalingam – DD(F) and Manager-TEV took them around the campus and explained the varied activities in TEV.

16th March: Shri. Shivakumar Gandhigram Trust, visits TEV.

Shri. Sivakumar, a well known chartered auditor and treasurer of Gandhigram Trust visited TEV on 17th march. He chats with the residents, donated siddha medicines worth Rs.4000 and Rs.1000 as cash conation. He visited some of the villages, met VLF/DLF leaders and was very much impressed with HI activities in Cuddalore. DD (F) Mr.Ramalingam, Dr.Sathiyababu and Mr.Elango accompanied him. Siddha Dr. Mariappan accompanied him who gave presentation during the Livelihood workshop organised by EfE on request of Shri. Arunachalam, Managing Trustee.



17th March: Hon'ble Judges of Cuddalore district visits TEV



Shri.Rampathiran, District Sessions Judge, Shri.Ashokan – Additional District Judge, Shri.Zakir Hussain, chief judicial magistrate Cuddalore visited TEV on the evening of 17th March. They met individual residents, enquired about their well being, food, clothing etc. EfE Managing Trustee and PMO staff accompanied them.

17th March: Elders' Rights and Livelihood workshop @ TEV

The coastal resources centre for elderly and Elders for Elders Foundation organised this advocacy workshop at TEV campus on 17th March. In this full day workshop a series of lectures and group discussion were arranged by Advocacy executive Ms.Rajalakshmi. About 35 VLF/ DLF representatives attended. Mr.Vedanayagam, Senior Advocate explained the participants about the Parents welfare Act 2007 in Tamil with LCD presentations.





The District sessions judges while addressing the workshop meet, agreed to give support in implementing the "District Elders Grievance and redressal committee" in Cuddalore to solve many of the elders' issues. He also agreed to give space in the court for Elders Help Centre.

19th & 20th March: Head- HR and Director- Health visits TEV

Ms.Paromita Thomas, Head-HR, HAI visited TEV on her official visit to Chennai. On 19th March, She was explained about all the project activities by the concerned project managers and DD (F) Mr.Ramalingam. She addressed the PMO staff meeting on 19th evening and explained about the importance of Cuddalore pilot projects and HO New Delhi official's keen interest in PMO activities. Dr.Jaideep, Director, Health explained about the centralised purchase of medicine at HO and requesting through MIS. He informed about new Doctor's appointment as a Project Manager for Palliative care project and his role, reporting to HO etc. Earlier HR madam gave an orientation on HelpAge India's objectives and goals to all staff.



20th and 21st March: Palliative Care Training Programme for Health Professionals:

A two days training programme for health care professionals on Palliative Care was conducted by Project Kiran staff and IPM calicut at TEV campus. The programme was inaugurated with a lighting of lamp by Head-HR Ms.Paromita Thomas. About 27 Doctors from all taluks of Cuddalore District. faculty of community medicine, PIMS and AVMC attended. During this two days training headed by Dr.Mathew of IPM, the participants were explained about geriatric medicine, palliative care, treatments, integrated caring etc. The entire programme was arranged by Ms.Subha and Dhava team on advice of Dr.Sathiyababu.
